## President's Report to the Fifth Annual General Meeting 21 September, 2011.

I have much pleasure in presenting the President's Report to the Fifth Annual General Meeting of ECCO Orange Inc.

ECCO Orange was launched in April 2006, and for the past five years has worked extremely hard to achieve its aims as initially conceived with regard to environmental education, awareness and activism, and climate action in the Orange community,

ECCO General Meetings and Public Meetings continue to be held on the 4<sup>th</sup> Wednesday of each month, at the Environmental Learning Facility (ELF) at the Orange Showground, and Committee Meetings, open to all members, are held regularly on the 2<sup>nd</sup> Monday of each month. Wherever possible General Meetings aim to address current and critical environmental issues, and when special guest speakers are invited, these meetings are widely promoted as a Public Meeting and usually attract up to 80 persons, with ECCO business being kept to a minimum. Committee Meetings spend considerable time on the planning of events, campaigns and submissions.

During the latter part of 2010 and early 2011, considerable effort was put into the campaign to ensure Orange's neighbourhood parks, the Ploughmans Creek Wetland and the Bloomfield Bushland were zoned for public recreation or environmental management in the new Orange Local Environment Plan. This effort was rewarded when Orange City Council agreed to change the draft LEP to address these issues. Park surveys, community meetings and rallies, and significant media exposure ensured overwhelming community support.

Unfortunately submissions objecting to the rezoning of the DPI land at Bloomfield, and the subsequent Concept Plan for residential development were largely rejected by the Department of Planning. However some of ECCO's criticism of lack of open space and layout resulted in some minor modifications to the plan. A final decision by the Department of Primary Industry as to whether or not they will in fact proceed with the sale of Research Station land is still pending.

A summary of ECCO's main achievements and contributions during 2010/ 2011 reveals the extent of our commitment to fulfilling our aims; something all members can be very proud of.

The ECCO Committee of Peter West, Stephen Nugent, Nick King, Phil Stevenson, Tony Smith, Susan Sanders, Col Foster, Brian Phillips, Yvette Black, Simon Wright and Rod Holcombe have met monthly throughout the year between General Meetings and deserve special acknowledgement.

A recent decision to provide drinks and nibbles after our monthly meetings has been welcomed and appreciated by members and visitors, and thanks go to Jenny and Tony Smith for organising this.

It is appropriate to make special mention and thank our treasurer, Col Foster who will be leaving Orange shortly to reside in the Blue Mountains. Col has made an invaluable contribution to ECCO since its inception and has been an enthusiastic participant in all activities and he will be greatly missed, not only by ECCO but also by the Daroo Orange Urban Landcare Group which he has so capably led for many years.

I would like to take this opportunity to thank all members, supporters and friends who have contributed to the success of ECCO this year. It has been a great honour for me, once again, to have served as President of an organization with passionate, committed, and genuinely nice people.
